WARM-FM'S "APPELL CENTER CROCE PLAYS CROCE TICKET GIVEAWAY AUGUST 19-23, 2024" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WARM-FM ("Station"), owned and operated by Susquehanna Radio LLC or one of its affiliates, 2300 Vartan Way, Suite 130, Harrisburg, PA 17110, during available business hours Monday through Friday, on the Station's website: www.warm1033.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WARM-FM's "Appell Center Croce Plays Croce Ticket Giveaway August 19-23, 2024" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months. Void where prohibited by law. - 2. Contest Period. The Contest will begin at 3:00pm ET on August 19, 2024 and run weekdays from 3:00pm ET to 7:00pm ET through 7:00pm ET on August 23, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter and win. Listen to the Station during the Contest Period. When the Station gives a cue to call, listeners must call the Station at 1-855-927-6103. Caller #10 to the Station, as determined by the Station in its sole discretion, will be eligible to win the prize after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast*: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. LIMIT ONE PRIZE PER PERSON.
- 4. Verification of Potential Winner. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.
