WARM-FM's "JESSIE'S GIRL LADIES 80S NIGHT ONLINE RTW MARCH 24-30, 2025" CONTEST OFFICIAL RULES

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility.
